## **Dallas County District Attorney's Office U Visa Nonimmigrant Status Presumptive Certification Policy**

The Dallas County District Attorney's Office ("DCDAO") encourages victims to report crimes, contribute to investigations, and assist prosecutions regardless of immigration status. The DCDAO encourages those who believe they are eligible for a U Visa to request certification of a USCIS Form I-918 Supplement B, U Nonimmigrant Status Certification (Form I-918B).

Immigrants, especially women and children, can be particularly vulnerable to crimes like human trafficking, domestic violence, sexual assault, and other abuse due to a variety of factors. These include, but are not limited to, language barriers, separation from family and friends, lack of understanding of U.S. laws, fear of deportation, and cultural differences.

The U Visa is an immigration benefit that can be sought by victims of certain crimes who are currently assisting or have previously assisted law enforcement in the investigation or prosecution of a crime, or who are likely to be helpful in the investigation or prosecution of criminal activity. The U Visa provides eligible victims with nonimmigrant status in order to remain temporarily in the United States (U.S.) while assisting law enforcement. If certain conditions are met, an individual with U Nonimmigrant Status may adjust to lawful permanent resident status.

**DCDAO will certify cases in which we can confirm that a victim is currently assisting or has previously assisted in the investigation or prosecution of crime, or is likely to be helpful in the investigation or prosecution of crime. DCDAO will use records, case files, and prosecutor and advocate notes to confirm cooperation.**

"Assisting" or being "helpful" includes, but is not limited to: communicating in person or through correspondence with DCDAO advocates, staff and prosecutors, providing information, supplementing police reports and recorded statements, or testifying in trials and hearings when reasonably requested. **DCDAO will not certify Supplement B requests for those not assisting or being helpful to the investigations or prosecutions of crime.**

DCDAO will exercise its discretion to certify U Visa requests on a case-by-case basis, consistent with applicable U.S. laws and regulations and the policies and procedures of the Department of Homeland Security. DCDAO may withdraw or disavow a certification of Form I-918B if an eligible victim stops cooperating before or after the disposition of a case.

DCDAO will only certify a U Visa one time per eligible victim, eligible immediate family member or indirect victim.
