

	Driving Safety Course (DSC)	Deferred Disposition
Eligibility	<ul style="list-style-type: none"> • Must have a valid Texas Driver’s License and valid liability insurance • Must NOT hold a Commercial Driver’s License (CDL) • Must NOT be taking DSC for another offense in this court or any other court • Must NOT have had a ticket dismissed through a Driving Safety Course in the 12 months preceding the date of offense • Must enter a plea of “Guilty” or “No Contest” • Must submit the request for DSC on or before the appearance date given on the citation 	<ul style="list-style-type: none"> • Must have a valid Texas Driver’s License, valid liability insurance, and current Texas motor vehicle registration • Must NOT hold a Commercial Driver’s License (CDL) • Must enter a plea of “Guilty” or “No Contest”
Offenses Excluded	<ul style="list-style-type: none"> • Offenses that are NOT moving violations • Offenses in construction zones when workers are present • Speeding 25 mph or more over the posted speed limit, or at a speed of 95 mph or more • Passing a School Bus • Reckless Driving • Fleeing/Eluding Police • Failure to Stop and Render Aid • Failure to Stop at Accident: Damage 	<ul style="list-style-type: none"> • Offenses in construction zones when workers are present • Any offense according to the Judge’s discretion
Length of Probation	<ul style="list-style-type: none"> • 90 days 	<ul style="list-style-type: none"> • 1 day to 180 days at the Judge’s discretion
Costs Up Front	<ul style="list-style-type: none"> • Offenses: \$146.00 • Offenses in school zones: \$171.00 <i>(subject to change according to law)</i> 	<ul style="list-style-type: none"> • Deferral fine, fees, and court costs <i>(contact court for total amount)</i>
Extra Expenses	<ul style="list-style-type: none"> • Driving Safety Course: \$25 to \$100 • Certified Copy of Driving Record: \$10 	<ul style="list-style-type: none"> • Drivers under age 25 must complete a Driving Safety Course: \$25 to \$100 • Drivers who hold a provisional license must complete a DPS exam: \$10
Conditions of Probation	<ul style="list-style-type: none"> • Must complete an approved Driving Safety Course • Must obtain driving record from DPS 	<ul style="list-style-type: none"> • Must submit all required documents as ordered by the Judge
Result of Compliance	<ul style="list-style-type: none"> • Case will be dismissed • DPS will be notified of the of the successful completion of a DSC 	<ul style="list-style-type: none"> • Case will be dismissed • No conviction will be reported to DPS
