Bids received at 2:01 p.m. and thereafter are Late Bids and will not be accepted, opened nor considered.

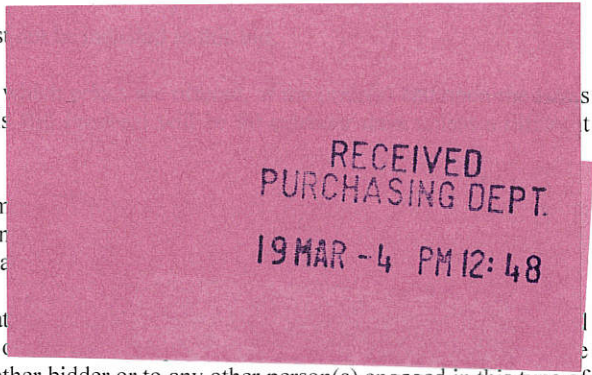

After the official opening, bids may not be amended, altered, or withdrawn without the recommendation of the Purchasing Agent and the approval of the Commissioners' Court.
