### MUNICIPAL ADVISOR (IRMA) EXEMPTION

August 29, 2015

By publicly posting the following written disclosure Dallas County, Texas (the "County") intends that municipal market participants receive and use such disclosure for purposes of the independent registered municipal advisor exemption to the SEC Municipal Advisor Rule (Section 15B of the Securities Exchange Act of 1934).

The County has retained independent registered municipal advisors. The County is represented by and will rely on its co-municipal advisors, RBC Capital Markets, LLC ("RBCCM") and TKG & Associates LLC ("TKG"), to provide advice concerning the issuance of municipal securities, the investment of bond proceeds and escrow investments. The individuals with primary responsibility for advising the County are Matt Boles and Julie MacMillan with RBCCM and Charlotte Knight-Marshall and Janice D Davis with TKG. Mr. Boles has been associated with RBCCM for more than twenty years and Ms. MacMillan has been associated with RBCCM for seven years. Neither has been associated with another broker-dealer or municipal advisory firm in the last two years. Ms. Knight-Marshall has been associated with TKG for more than 27 years and Ms. Davis has been associated with TKG for one year. Neither has been associated with another broker-dealer or municipal advisory firm in the last two years.
